I have reviewed the documents you sent. The following are my recommendations. Follow them, and the probability for your petition to be smoothly and speedily approved will be greatly enhanced. If you have any questions please call 1-800-806-3210 x 702 or email me.

You provided the materials loose, and unbound in manila folders. The review is more definitive when you send me a "ready to submit", near final, complete version of your petition, prepared to the best of your abilities. I have done the best I can with what I got.

Do not submit your petition this way to USCIS. One set of documents bound together with acco fasteners is the preferred way to assemble the petition. When you finalize the package use a two hole punch and acco fasteners. Punch holes at the top of each page.

Handwriting is nice, clear.

Cover Letter

Missing. You should provide an itemized list of petition contents (see sample attached)

I-129F re: "part B, Question 18"

30 years is a significant age difference. Expect your petition to attract extra scrutiny. The repeated emphasis of the financial aspects of your relationship will get you into trouble. While wanting to support your wife is commendable, so much emphasis on the generosity you are now showering onto your girl friend/ fiancée is not advisable. To avoid skepticism describe your relationship in romantic, person to person, compatibility terms, do not bring unwanted attention to the economic disparities between you and her.

Therefore, I suggest you rewrite this as follows :

Include the name of the web service where you met. Saying "we met in an (unnamed) Social Networking Site Chat Room" sounds evasive and will probably make that an unwelcome topic during her interview. If you have not violated IMBRA laws, and the site is legitimate, state it's name..

Remove all references to the monies, gifts, and support you are providing.

Replace them with a "low key" comment on finances. Like "Since our engagement, I provide her monthly financial support. I also support her enrollment in nursing school, so that she will be better prepared to fit in as a productive US citizen once she joins me in America."

Remove reference that she stayed with you in a hotel in Manila the first time you met in person.

Your timeline of three visits, and your comments that you keep regular contact, that you met her family, and they like you, are all good and should be kept.

A major deficiency in the text is the absence of many of the issues which genuine couples planning a new future together discuss or are concerned about. Add to your description answers to the following questions.

Why did you choose her?

What is she like?

What features, attributes do you find most attractive?

What do you talk about?

Why do you want to marry her?

What do you have in common: values, interests, goals, religion?

Why did she choose you? (not your generosity)

What are your plans for the future together?

What are your plans for the wedding ceremony?

What are plans for honeymoon?

What are your plans for establishing a household?

Are you planning a family?

After marriage, do you have plans about work for your spouse?

Where do you plan to live after marriage? – what kind of house, where, buy rent?

What preparations are you making for her arrival?

What do you expect to happen within a year of marriage?

What do you expect to happen after 5 years of marriage?

Plans for vacations together?

Plans for social, hobbies, educational interests?

Both parent's birthdates are missing. As both are alive, and since you met them, this seems odd.

Various Receipts

Choose only those that are relevant. Start with copies of the pages from your passport showing the Phil Immigration entry/exit stamps from all three trips. (These should be **in addition** to the full set of copies of each page from your passport). Then add the flight itineraries, or tickets from each trip, and the receipt for the engagement ring.

The other receipts, meals, hotels, general purchases are not relevant.

Photos

The Photos you chose are fine. You mentioned three trips. I only see photos from two trips. Missing are photos from the July 2008 trip. You mentioned a "formal engagement" in April. Include photos from the engagement party or her showing off the ring on her finger.

Copies of Money Transfers

Not relevant

Correspondence

They look ok. But there are none from 2008. Basically every few months since the start of your relationship you should pick a few samples of emails, IMs, skype or telephone bills. The purpose is to show a continuing ongoing relationship. Choose those that are on topics personal, romantic, or about plans for the future, but NOT financial.

Correct what you need to, then finalize the package and put it into order. Do not send originals to USCIS. Replace originals with clear legible copies. I recommend you make two copies of the final package, one for you and one for your Fiancee. Then after making copies, use a two hole punch and acco fasteners. This is the how I make all the packages I prepare start-to-finish. You can find a two hole punch at a copy shop. Also in the final petition to be sent to USCIS I always attach tabs to the bottom of the first page of each section. This makes it easier for the reviewer to quickly see any document he needs.

What you should do now:

- A. Assemble the petition. Make changes as needed.
- B. Sign and Date wherever indicated.
- C. Make copies. Bind package.
- D. Attach Check for \$455 made payable to “US Department of Homeland Security”
- E. Your petition should be sent directly to:
